Our **RTI Payroll Standard** software provides the following functionality:

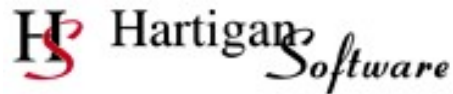
- Calculation of PAYE Tax, National Insurance Contributions, and Student Loan deductions

Hartigan Software currently offer three RTI submission products, **RTI Pro**, **RTI Lite**, and **RTI Payroll**. Our software runs on Microsoft Windows operating systems.

While many other products require data to be uploaded to a third party server, RTI Payroll Standard removes this requirement, it is a desktop application which provides a direct connection to the Government Gateway. RTI reports are generated and submitted from the end user's PC straight to HMRC. This removes any dependency on third party web services and avoids potential data security issues.
